# **Privacy Policy**

As user of the website (referred to as "you/your") you acknowledge that any use of this website (including any transactions you make) is subject to this Privacy Policy together with our Terms and Conditions.

This privacy policy sets out how Book Driving Theory uses and protects any information that you give us when you use this website.

Book Driving Theory is committed to ensuring that your privacy is protected. Should we ask you to provide certain information by which you can be identified when using this website, then you can be assured that it will only be used in accordance with this privacy statement.

#### Introduction

test certificate photo or copy

demographic information such as address, postcode, preferences and interests

credit/debit card or other payment details

other information relevant to customer surveys and/or offers

## What we do with the information we gather

We require this information to understand your needs and provide you with a better service, and in particular for the following reasons:

- (a) to register you with our website and to manage any account you hold with us.

#### Data retention period

- (d) to anyone to whom we transfer our rights and duties under our agreement

with you.

(e) if we have a duty to do so or if the law allows us to do so.

## What legal basis do we have for processing your personal data?

#### How we use cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive.
